

Memorandum of Understanding

This Memorandum of Understanding is being signed between the Chairman/Owner, Rice Mill Bindki Fatehpur (hereinafter called the First Party) and Principal, Government Girls PG College Bindki Fatehpur (hereinafter called the Second Party) whereby it is mutually agreed as follows:

1. That both parties agree to enter into an MoU solely for academic purposes.
2. That both parties are aware that neither party will pay any students or faculty coordinators for participating in any internship, academic activities, site visits, etc.
3. None of the parties to this Memorandum of Understanding is subject to any financial obligations.
4. This Memorandum of Understanding aims at providing students with practical training, industrial exposure, and skill development opportunities at the Rice Mill Bindki fatehpur.
5. Dr. Gyanendra Pratap Singh, Assistant Professor, Department of Economics, Government Girls PG College Bindki Fatehpur and the Chairman/Owner, Rice Mill Bindki Fatehpur shall act as faculty co-ordinators for the execution of the above MoU. Both of them will serve as the primary liaison between the two institutions to facilitate the development of future activities.

Types of Cooperation

Through this MoU, both parties affirm to value interdepartmental inter-collegiate collaboration and agree to promote the following academic activities:

1. Training in paddy cleaning, drying, milling (husking), grading, and packaging processes.
2. Practical knowledge of machine operation and maintenance.
3. Study of quality control and storage management.
4. Industrial visits and project-based practical learning.
5. Further actions decided upon by the signatories in mutual agreement.


Commencement, termination and amendment

This MOU will come into force from the date of affixing of the signatures of the representatives of the both institutions and will remain in effect for five years. If either organization wishes to terminate the MOU at the end of the five years period or in between the period of five years, it must notify the other organization not less than one month prior to the expiry of the MOU. The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. Modifications to MoU will be made by mutual consent and any amendment or extension to the MoU will be formalized by the exchange of letters and or emails between the two organizations.

Resolution of Disputes and Governing Law:






